The terms & conditions, rules & regulations for the elections to be conducted for the various posts of office bearers of BDS are as follows.

**The nominations are invited for the following posts:**

1. President - One post
2. Vice-President - Two posts
3. Honorary Secretary - One post
4. Treasurer - One post
5. Joint Secretary - Two posts
6. Members of the executive committee Five Nos + 5 (for additional strength) = 10 One additional member shall be added for every 50 members or part there of beyond a total membership of 550.

**\*The immediate past President, Secretary and Treasurer shall be ex-officio members of the Executive committee for the whole term.**

**\*Eligibility for the post of President:**

- (I) Founder members of BDS or
- (ii) Members with at least seven years' of continuous life membership of the society and having held the post of:
  - (a) Vice-President or Secretary of BDS for at least one term
  - (b) President / Vice-President / Secretary of IADVL at the National level or any other Sister Organization at the National level for at least one term in the past shall be eligible to contest for the post of President.

**\*Eligibility for the post of Vice-President:**

- (I) One post of Vice-President shall be open to nomination of a member with at least fifteen years of life membership of the society.
- (ii) Members with at least five years of continuous life membership of the society and having held the post of Secretary or Treasurer for at least one term shall be eligible to contest for the other post of Vice-President.

(iii) Senior Vice-president shall be the one with the longer duration of membership of the Society.

**\*The post of President and Vice-President cannot be held by the same individual for more than one term.****\* Eligibility for the posts of Secretary and Treasurer:**

Members with at least four years of continuous life membership of the society and having held the post of joint secretary / executive committee member for at least one term in the Past shall be eligible to contest for the post of Secretary or Treasurer.

**\*Eligibility for the posts of Joint Secretary :**

Members with at least three years of continuous life membership of the society and having held the post of executive committee member for at least one term in the past shall be eligible to contest for the post of Joint secretary. Senior Joint Secretary shall be the one with longer duration of membership of BDS.

**\*Eligibility for the posts of Executive Committee Member :**

Members with at least three years of continuous life membership of the society shall be eligible to contest for the post of executive committee member.

**\* Executive Committee Member who fail to attend at least fifty percent of the executive committee and other meetings of the society during an association year shall be replaced by other eligible members for the second year of the tenure of the team in office by way of nomination by the executive committee.**

**\* The term of the Office-bearers shall be for TWO years.**

**\* New team of office bearers shall take over office during the month of June of alternate Year (2021,2023, and so on)**

**\* It shall be responsibility of the Treasurer and the team holding**

Office to get the accounts finalized and audited before handing it over to the new team.

**\*The general body meeting shall be conducted during every year of the association by giving at least fifteen days advance notice.**

**\*The Executive committee shall meet at last four times during one association year.****\* Advisory Committee of the Society :**

BDS members who are Heads of Department of Skin & STD at different Medical Colleges who regularly host one monthly meeting of BDS every year, shall be members of the advisory committee.

All past presidents, secretaries and treasurers of BDS, IADVL at the national level and other sister organizations at the National level, who are members of BDS, shall be permanent invites for the advisory committee.
